## Electronic Payment Options for Quarter-Monthly (Weekly) Sales Tax Filers

<u>12 CSR 10-104.050</u> Sales and Use Tax Return, If your business reports sales or use tax from 3 or more locations, you are required to file your sales and use tax returns electronically. Returns can be conveniently filed electronically through our Mytax Missouri Portal at <u>mytax.mo.gov</u>.

If you are not yet registered for this service, you can file as a guest user. You can download a file of your registered locations and tax rates at mytax.mo.gov/rptp/portal/home/locations-listings.

If you are unable to submit your sales or use tax returns electronically or need additional time to establish your electronic filing method, you may complete Form 5849 to request a waiver from the electronic filing requirement. This waiver is only valid for one year after the date of submission and is located on the Department's website at <u>dor.mo.gov/forms</u>.

#### **Option 1:**

Sales tax payments may be made online using a credit card or Electronic Bank Draft (E-Check) by accessing our website at: <u>mytax.mo.gov/rptp/portal/home/fileandpaybusinesstaxesonline</u>.

- All valid sales and use tax filers (with account in an active status) can use this system and there is no registration.
- From the address above, click Pay Quarter-Monthly (Weekly) Sales Tax Payments and follow the screens.
- The system will ask for Missouri Tax ID Number, Year, and Month of Payment, Period Number (1-4 for prepayments), and the amount of payment.
- Other payment information will be needed such as name, address, credit card number, or bank routing and account number, etc.
- A payment can be scheduled up to 45 days in advance.
- The postmark date of the transaction is the date the payment is effective.
- The payment will process within two banking days of the effective date.

Sales tax payments may also be made using the Automated Clearing House Credit (ACH) method.

- To make payments through the ACH Credit Payment method, you must make arrangements with your financial institution or service provider to originate the transaction and pay the associated costs.
- You must work with your financial institution or service provider to ensure that the required "TXP" tax information is transmitted with the payment. The Electronic File Specifications and Record Layouts for EFT of Business Tax Return and Payment Using ACH Credit with TXP Addendum (Form 4585) may be used for reference.
- After sending a pre-notification test, please contact the Department at (573) 751-8150 to verify if the test was successful.
- The postmark date of the transaction is the Federal Reserve settlement date.
- · Work with your financial institution or service provider to ensure payments are timely.
